A1 	Motorcycles with an cylinder capacity not exceeding 125 cubic centimetres, with a power rating not exceeding 11 kW and with a power to weight ratio not exceeding 0.1 kW/kg. Tricycles with a power rating not exceeding 15 kW.
A2 	Motorcycles with a power rating not exceeding 35 kW, with a power to weight ratio not exceeding 0.2 kW/kg and not derived from a vehicle of more than double its power.
A 	Motorcycles – two wheeled vehicles with or without sidecar - with a power exceeding 35 kW or with a power to weight ratio exceeding 0.2 kw/per kg, or - with a power not exceeding 35 kW with a power to weight ratio not exceeding 0.2 kW/kg and derived from a vehicle of more than double its power. Tricycles. Three wheeled vehicles with a power exceeding 15 kW.
B1 	Quadricycles, as defined in Article 1(3)(b) of Directive 2002/24/EC.
B 	Vehicles (other than motorcycles, mopeds, work vehicles or land tractors) having a Maximum Authorised Mass ("MAM") not exceeding 3.500kg, having passenger accommodation for not more than 8 persons in addition to the driver, including a combination of any such vehicle with a trailer where the MAM of the trailer is not greater than 750kg. Also, such vehicles with a trailer more than 750kg provided the total weight of the vehicle and trailer does not exceed 3.500kg. Quadricycles (other than those covered by AM) are also covered by this category.
