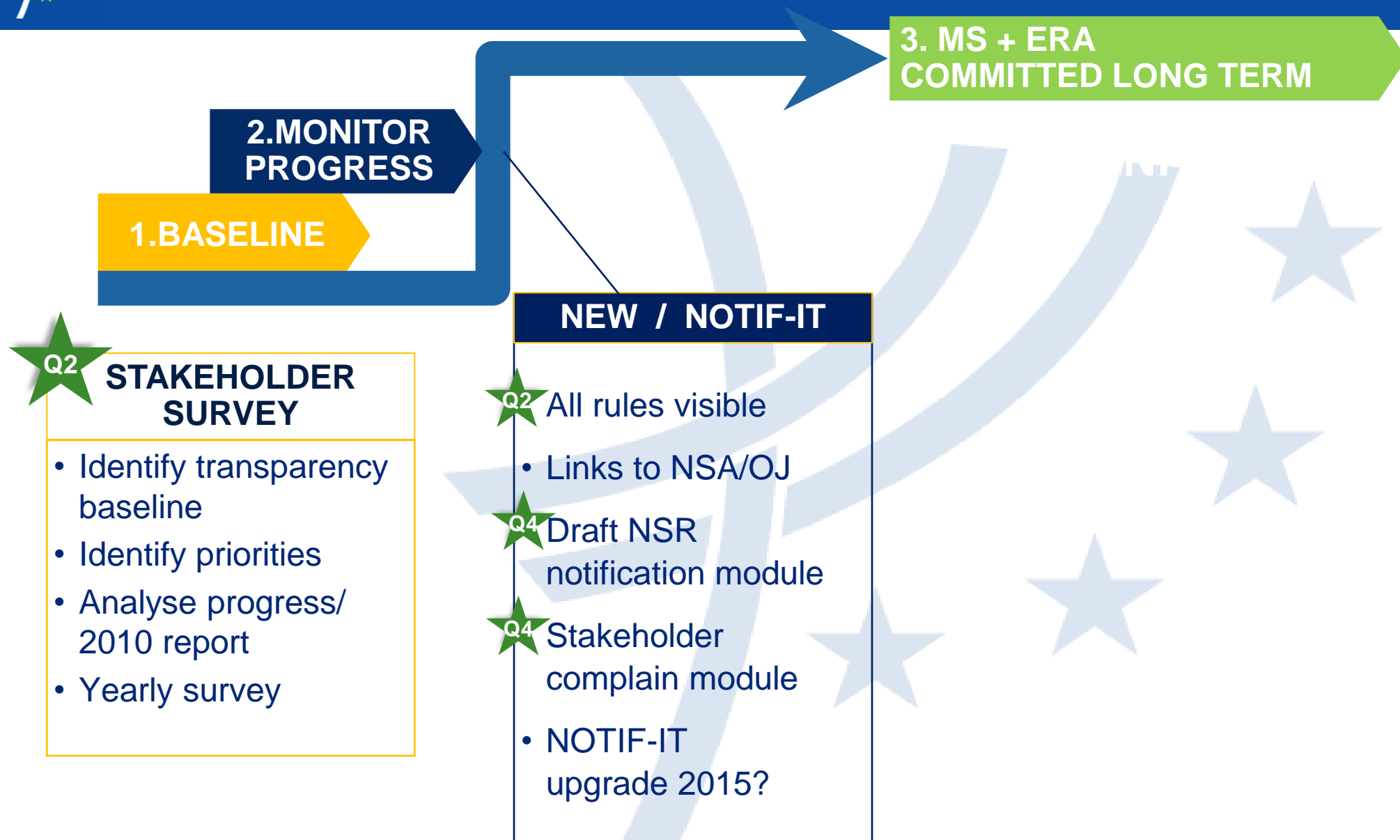

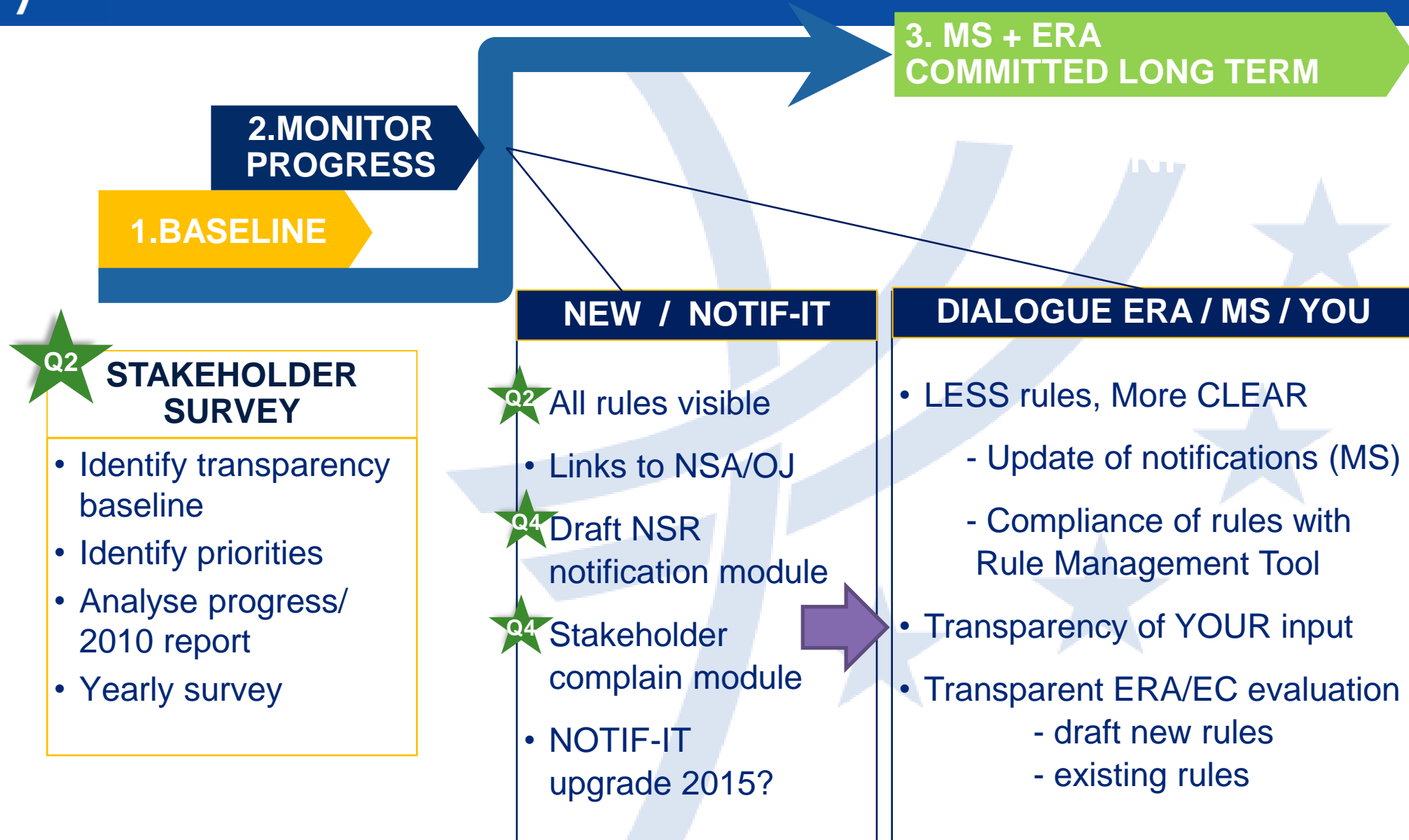

- NSA transparency survey
 - National Safety Rules and transparency on the agenda when NSA of EU Member States meet
 - Rule Management Tool (RMT)
= EU consensus on what can be NSR
- 2014 update/new TSI
-2015 draft EC Decision
-2015 Rules in NOTIF-IT
are classified with RMT
